2017 NWCC Assessments

As approved at the October quarterly meeting, the Nottingham West Civic Club annual assessment has increased for 2017 by 1% to \$620.88, per lot. Assessments are payable in two installments, January and July. Statements for the first payment of \$310.44 were mailed December 12 and are due by January 1, 2017. If you did not receive a statement, please contact Staci Tucker at 281–945–4651 to request a replacement and confirm your mailing address. Assessments may be paid online through the Crest Management website at <u>www.crest-management.com</u>.

A late fee of \$20 will be charged for accounts outstanding as of January 31 with an additional fee of \$40 if still unpaid as of February 28. Accounts not paid by March 31, 2017 are subject to legal action. A finance charge of 18% per annum will be assessed on all unpaid fees after January 31, 2017.

Terry Hershey Park Partially Closed

Terry Hershey Park **north of Buffalo Bayou from Kirkwood Rd. to Beltway 8/Sam Houston Tollway** is closed so that the Harris County Flood District (HCFD) is able to complete an emergency repair project and to minimize risks to bike riders and pedestrians. Terry Hershey Park north of Buffalo Bayou from Kirkwood Dr. west to Highway 6, and the entire park on the south side of Buffalo Bayou from Beltway 8 to Highway 6 remain open.

Closure in the repair area is effective immediately and will last until bank stabilization repairs are complete. Harris County Constables will be patrolling the closed area and issuing citations to trespassers. For your own safety, please completely avoid this area of Terry Hershey Park. voting proxy was mailed to all homeowners in December.



Kirkwood Rd Construction

The Nottingham Task Force (NTF) is working on behalf of area residents to replace the current City of Houston Public Works and Engineering (PWE) plan for the Kirkwood reconstruction project with the Nottingham Task Force Plan. The NTF Plan replaces the on-street bike lanes with eight-foot dual use pedestrian/bike pathways located behind the curb, eliminates all of the left turn lanes except for the Kimberley and Memorial intersections, and preserves our median and trees. NTF heard that over 800 responses were received by PWE following the July 27th meeting with Councilman Greg Travis and believes that responses overwhelmingly support the Nottingham Task Force Plan and will greatly influence the final design for Kirkwood.

The Task Force met with several Council Members, BikeHouston, Memorial Super Neighborhood 16 and Kirkwood neighbors south of Memorial to garner additional support for our opposition to the PWE plans. An agreement has been reached with BikeHouston and NTF is optimistic this will resolve the bike lane issue. The Nottingham Task Force expects to meet with the City shortly and is seeking flexibility from the PWE to eliminate plans for left turn lanes except at Kimberley and Memorial and to accept the joint agreement with BikeHouston.

The Nottingham Task Force will keep residents updated on discussions and any decisions. Many steps remain in the process to modify this project to an acceptable Kirkwood design. The Task Force may need your help again as we move forward with our fight for the neighborhood. Stay Tuned!

NWCC Committee Updates

The **Audit Committee** is getting ready to put together a one-page report that will summarize business and financial history in 2016. The members of the committee include NW homeowner John Knobelsdorf and NWCC Director Reed Brown.

The **Bylaws Committee** has been working continually since August on recommended changes to our 1980 bylaws. The five-person committee has completed its review and is in the process of editing its detailed recommendations. The two goals of the committee were: 1) propose amended bylaws that are consistent with current state laws and 2) propose amendments to our current bylaws that are required and amendments that provide clarity and efficiency for NWCC management.

After reviewing the bylaws of our neighboring HOAs, the committee will be recommending significant changes that it believes will adequately address the challenges to 1) having an engaged Board of Directors and 2) finding replacement officers. The committee set out to maintain current NWCC homeowner control and still address the challenges we encounter. The highlights of the committee's recommendations are:

State-mandated updates:

- Notices of meetings: 10 days minimum, 60 days maximum
- Proxies must be required for the election of Directors
- Members with outstanding balances are allowed to vote on civic club decisions
- Members may convene to hold votes

Additional committee recommendations:

- Increase the size of the Board of Directors from three to nine members
- Directors are elected by NWCC members for two-year terms
- Directors select officers from among nine Board members
- Update spending authority of officers and Board of Directors to realistic levels

Update bidding requirements to realistic levels

- Continue to require NWCC members to approve annual budget
- Require member vote on key contracts
- Allow Board to act in emergency
- Provide for NWCC members to vote absentee ballot or proxy for key decision-making
- Requiring Board of Directors to approve deed restriction violation notices
- Establishing clear requirements to change bylaws 30% of members (105 members)

The recommendations will be submitted to Rosanna Hinde for review by the officers and Board of Directors. The results of the Bylaws Committee's efforts will be addressed after they are received. The members of the committee include former NWCC officers, Kaitlyn Sharp, Steve Diserens, and David Peters, joined by NW homeowners Dan Whitton and Luis Miramontes.

MINUTES OF THE QUARTERLY HOMEOWNER MEETING OF THE NOTTINGHAM WEST CIVIC CLUB, INC., WHICH WAS HELD ON OCTOBER 12, 2016 AT THE NOTTINGHAM PARK MEETING ROOM LOCATED AT 926 COUNTRY PLACE DRIVE, HOUSTON, TEXAS 77079.

DIRECTORS AND OFFICERS PRESENT: Rosanna Hinde, Angie Lootens, Pam Ziegenbein and Reed Brown (past President).

DIRECTORS AND OFFICERS ABSENT: Mark Dessens (past President).

IN ATTENDANCE: Hayley Rayder and Lucea'n Kuykendall, representing Crest Management.

CALL TO ORDER: The meeting was called to order at 7:35 p.m. with 25 lots represented in person.

ADOPTION OF AGENDA: Motion was made, seconded and carried to approve the Agenda as presented.

ADOPTION OF MINUTES: Minutes of the Quarterly meeting held on July 20, 2016 were approved.

CONSTABLE'S REPORT: The Constable reported that there have been car burglaries and most of the cars were left unlocked. There have also been reports of suspicious vehicles in the community but it was determined that most of them were the Amazon delivery drivers.

OFFICER REPORTS:

a) President – Rosanna Hinde

Director Hinde discussed two issues at hand – the pool slide and the replacement of 5 ceiling fans at the pool. Director Hinde instructed Crest to send her the budget showing the approved 1% increase in HOA dues and to review the pool expenditures to make sure billing was accurate.

b.) Treasurer – Pam Ziegenbein

Agent to review financials.

c.) Secretary – Angie Lootens

Reported typo in newsletter - Halloween parade is October 31, 2016.

COMMITTEE REPORTS:

a.) **Architectural Committee:** Preston Mood reported for the ACC that there are several homes for sale in the community and no major ongoing projects taking place at this time.

b.) **Nominating Committee:** Ms. Nancy Bailey reported that they are still looking for members willing to run for officer positions. They are also looking for volunteers to serve on a social committee.

c.) **Audit Committee:** Mr. Reed Brown reviewed the association financials and explained that the major expenses of the association are set expenses that do not change. He explained that the reserve money was used for the park construction and the rest was used to re-plaster the pool.

d.) **By Law Committee:** David Peters reported that they are still reviewing the current by laws. In order to get a better understanding of how other HOA's by laws read, they reviewed several neighboring HOA by laws to compare. They are not ready to make official recommendations at this time but are actively working in this project and will present their formal recommendations once they are complete.

NEW BUSINESS:

a.) 2017 Budget

President Rosanna Hinde recommended a 1% increase to the association dues for 2017. Approved pending receipt of updated budget reflecting the 1% increase option.

- b.) Pool Votes
 - Pool Slide A homeowner made a motion to table the pool slide proposal. Motion was seconded and carried to table.
 - Ceiling Fans A homeowner made the motion to table the ceiling fan proposal. Motion was seconded and carried to table.

FLOOR MOTIONS: Director Hinde made a proposal to move quarterly meetings from Wednesday nights to Sunday nights but no motions were made.

ADJOURNMENT: There being no further business to discuss, the meeting was adjourned at 8:40 p.m.
